GUEST SPEAKER: Ann Marie Creamer – FC Recycling Program

Ann Marie was on hand to talk about the recycling program from the county. City residential areas are serviced by the county. It costs the county \$3.33/household/month to collect recycling. She also said that by removing the recycling stations throughout the county it will save 422k. Ann Marie also told residents that they can upgrade their recycling container at no charge. There is an additional charge if you would like an additional can. The range is \$40-47 and you will get that back when you return the can.
