## ***POLICE REPORT:*** Cpl. Alcorn

Cpl. Alcorn was on hand to discuss the statistics at the end of the minutes as well as address any concerns from residents. Cpl. Alcorn talked to residents about a new system that FPD uses. This system produces reports that show where the crime density is as well as times, dates, etc. This helps allocate resources to the appropriate area. Residents also asked about activity on Free Terrace and Cpl. Alcorn said that is was a medical issue.

**Project Name:** Kellerton Knolls  
**Applicant:** Yankee Land Trust – Keller Family  
**Planning Staff:** Jacqueline Marsh  
**Description:** The Keller property was annexed into Frederick City with R-4 zoning in September 2012. The Property subsequently gained PND Master Plan approval and APFO approval in September of 2013. The PND Master Plan provided for a maximin of 750 total units within the project and up to 130 units in Land Bay A. A project wide unit mix of 20-40% townhome sand 60-80% single family has been planned.

The applicant is requesting the required Preliminary Plan/Site Plan approval for 127 lots in Land Bay A. The applicant is also requesting Preliminary Forest Conservation approval for Phase I which includes Land Bay A, B, C and portions of the City Parkland.

### **Cpl. Vince Brown – Frederick Police Department Drug Enforcement Unit, Heroin Presentation**

Cpl. Brown was on hand to do a presentation on heroin. The presentation included what it looks like, what the effects are, why it is so addictive, how it is ingested, and why it has become so popular. He also talked about the department’s response to this such as education, outreach, and treating each scene (overdose, etc.) as a crime scene to go after those who sell this stuff. Cpl. Brown also distributed information about a program offered by the Health Department. This program is for community members who are interested in overdose prevention. If you have a loved one at risk for a heroin overdose or prescription pain medication, this training will teach you how to:

- The types of Opioids
- How to recognize, respond, and prevent an Opioid overdose as well as how to administer intra-nasal naloxone
- Right and responsibilities for those who choose to receive a prescription for naloxone
- Resources for Family Members, Friends & Loved Ones
