POLICE REPORT: Cpl. Alcorn

He also said there were 3 hit and run accidents all involving the same striking vehicle. Residents asked about graffiti and he said they are working to get it resolved.

Jenny was on hand to talk about a few of the initiatives she hopes to get going. She is currently working on increasing the tree canopy from 14% in 2010 to over 40%. She is also trying to get residents to plant trees. Residents were invited to attend the Green Team meetings on the 1st Monday of each month at 6:00 pm at the Annex.

This fall she will be conducting training for volunteers who are interested in identifying trees in their neighborhood so the city can have an inventory of what is out there. Jenny is also working on solar and wind projects.

- **Devon Hahn – City of Frederick Traffic Engineer 301-600-1443**

Devon was on hand to address any traffic concerns as well as talk about a few projects in the area. She talked about road improvements at the Keller Farm Property, Yellow Springs and Christopher’s Crossing. Residents also asked if she could look at the intersection of Rosemont & Tuscany as cars are frequently backed up there.
